My father said that if you want to be a king you should stay in your property no matter how small that is rather than in your wife's property. If in your wife's property and you quarrel with the wife she says this is my property, my father gave it to me; this might cause problems. So in the case of my family my mother moved to Umatac. And my mother gave the property to her bothers and sisters and they occupied the property. However, there is no recorded document of this and today I (Piling) am the Administrator for the property.

In the old Guam. custom if the husband died the property was owned by the wife and the children.

"In the old times if you and I are compadres I will tell you that you can get a piece of land if you baptize my child and especially if both were close relatives. Other times land would be enchanged for animals."

Land tranfer a very loose thing; a reciprocal type of arrangement. Land was not valued too much; no monetary value attached to it. Land was not sold but traded.

If my father gave me land and I sold it this was considered bad. People still abide by this. The Aguon family is a good example of this. The old people inthe family denot want to seell the land, for exam. Nan Ama. They considered it is $their\ land$ and want to keep it that way.

PLACE NAMES / BOUNDARIES / Knowledge of land

Often people do not know the lot number but they identify the land by the name. For example if I say Toguan they know right away what I am talking about. Or if I say Madog they know who used to stay in that parcel of land.

Boundaires of land are also connected with natural aspects of the terrain for example a river, certain trees. Also by the neighbor's owner of the next parcel of land. For example Antonio used to farm next to Luis in Cetti.
